## 7.1 Monitoring, Evaluating, and Updating the Plan

The plan participants listed above will ensure that a regular review and update of the *Multi-Jurisdictional Multi-Hazard Mitigation Plan* occurs. The Hazard Mitigation Planning Committee (HMPC) will continue to meet on a semi-annual basis, or as conditions warrant, to oversee and review updates and revisions to the Plan. The Canadian County Emergency Manager will continue to head the Staff Technical Advisory Committee, which will monitor and oversee the day-to-day implementation of the Plan. The Plan will be updated and resubmitted through the State Hazard Mitigation Officer for review and approval, and to FEMA no later than six (6) months prior to the end of the original performance period.

**Monitoring the Plan-** Monitoring of the Plan, the Action Plan, and Mitigation Measures is the responsibility of the Emergency Manager, City Manager(s), School Superintendents, and Floodplain Administrator(s). Departments responsible for implementation of the Action Plan and

the Mitigation Measures will update their Progress Reports on an annual basis, and report to the HMPC on progress and/or impediments to progress of the mitigation measures.

**Evaluating the Plan-** The *Canadian County Multi-Jurisdictional Multi-Hazard Mitigation Plan* will be continually evaluated by the Project Manager, and a report will be made to the HMPC twice each year. The evaluation will assess:

- adequacy of adopted Goals and Objectives in addressing current and future expected conditions;
- whether the nature and magnitude of the risks have changed;
- appropriateness of current resources allocated for implementation of the Plan;
- to what extent the outcomes of the Mitigation Measures occurred as expected;
- whether agencies, departments and other partners participated as originally anticipated.

Many Action Items recommended in this Plan have already been incorporated into the *Capital Improvements Plan* process for the County and individual communities. These programs will continue to be monitored and updated on an annual basis, if not more often.

**Updating the Plan-** The *Canadian County Multi-Jurisdictional Multi-Hazard Mitigation Plan* will be updated according to the following schedule:

1. Revise and Update- the county will incorporate revisions to the Plan document identified during the monitoring and evaluation period, as well as items identified in the previous Crosswalk.
2. Submit for Review- the revised Plan will be submitted to OEM and FEMA for review and approval.
3. Final Revision and Adoption- if necessary, the Plan will be revised per OEM and FEMA remarks, adopted by Canadian County, and the updated Plan sent to FEMA prior to the expiration of the 5-year approval period.

## 7.2 Public Involvement

*Canadian County and each participating jurisdiction* is committed to involving the public directly in updating and maintaining the *Multi-Jurisdictional Multi-Hazard Mitigation Plan*.

Copies of the Plan will be maintained at the Canadian County Courthouse, public libraries, and the Plan will be placed on the Canadian County Website.

A public meeting will be held prior to submission of the update of the *Canadian County Multi-Jurisdictional Multi-Hazard Mitigation Plan*. This meeting will be advertised to the general public, and will update residents on the progress that has been made in implementing the Plan and related capital projects. The meeting will also be used to distribute literature and inform and educate residents as to actions they can take to mitigate natural hazards, save lives, and prevent property damage. Input from the public will be solicited as to how the mitigation process can be more effective.

## 7.3 Incorporating the Multi-Hazard Mitigation Plan

The Hazard Mitigation Planning Committee recognizes the importance of fully integrating hazard mitigation planning and implementation into existing local plans, regulatory tools, and related programs; this process was used for the integration of the *2003 Canadian County Multi-Hazard Mitigation Plan*. The HMPC for *each* participating jurisdiction will ensure their jurisdiction

annually reviews any jurisdiction specific plans, ordinances, and codes identified in *Chapter 2, Appendices F and G* to incorporate the requirements of this plan and hazard mitigation practices, into those documents whenever feasible.

*Canadian County's* local planning mechanisms available for incorporating the recommendations and requirements of the Hazard Mitigation Measures are listed below. *Canadian County Multi-Jurisdictional, Multi-Hazard Mitigation Plan* will be approved and adopted by the Board of Commissioners as a guide to County mitigation activities.

The capabilities of Canadian County, the Towns of Calumet, Okarche and Union City, the Cities of El Reno and Piedmont, the Public School Districts of Banner, Darlington, El Reno, Maple, Mustang, Okarche, Piedmont and Union City, and the post-secondary educational institutions of Canadian Valley Technology Center District No. 6 and Redlands Community College to include mitigation in annual budgets, planning documents, and ordinances are described in *Section 2.3.6*.

Appropriate hazard mitigation information, action items and mitigation measures from the Plan will be incorporated into the following plans and codes adopted by Canadian County and participating jurisdictions, as applicable:

- Capital Improvements Plan and planning process
- Canadian County Building Code
- Canadian County Emergency Operations Plan
- Canadian County Water and Sewer Plan
- Individual Community and School District Emergency Operations Plans

The Canadian County Emergency Manager in conjunction with the Canadian County Hazard Mitigation Planning Committee will oversee the implementation of this plan once adopted. The process to include the adopted Mitigation Measures during the Hazard Mitigation Planning Process into other local planning mechanisms includes the following:

1. Mitigation Measures will be assigned to the appropriate departments for planning and implementation.
2. The responsible departments will report to the HMPC on an annual basis as to the progress made on each measure, identifying successes and impediments to their implementation.
3. Upon formal adoption of the *Canadian County Multi-Jurisdictional Multi-Hazard Mitigation Plan*, hazard analyses and mitigation goals will be incorporated into future versions of the *Canadian County Emergency Operations Plan*.

Each jurisdiction participating in this Plan is responsible for integrating mitigation measures applicable to their respective jurisdiction, and incorporating them into existing plans and codes, specific to their jurisdiction. Existing planning mechanisms adopted by each participating jurisdiction are described in *Appendices F and G*.

## RESOLUTION

### A RESOLUTION ADOPTING THE *CANADIAN COUNTY MULTI-JURISDICTIONAL MULTI-HAZARD MITIGATION PLAN*

---

**WHEREAS**, that portion of Canadian Valley Technology Center District No. 6 which boundaries fall within Canadian County, Oklahoma and its environs are subject to danger and damage from natural hazards such as flooding, tornadoes, high winds, lightning, wildfire and others;

**WHEREAS**, many agencies, organizations and businesses, including the federal government, have programs with financial and other resources that are dedicated to mitigate the vulnerability and impact of these hazards;

**WHEREAS**, the Board of Education of Canadian Valley Technology Center District No. 6 believes it would benefit from such mitigation resources and believes that a comprehensive, coordinated plan to assess the hazards faced by its campuses in Canadian County which plan develops strategies and measures that can eliminate or otherwise minimize the impact of these multiple natural hazards;

**WHEREAS**, Canadian County was awarded a Hazard Mitigation Grant Program planning grant in the amount of \$122,700 and Canadian County has provided local funds and in-kind services to prepare a multi-hazard mitigation plan for Canadian County, its incorporated and unincorporated towns, and its educational institutions;

**WHEREAS**, the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended, mandates that eligible jurisdictions must have a hazard mitigation plan approved by Oklahoma Emergency Management and the Federal Emergency Management Agency before applying for assistance through the Pre-Disaster or Post-Disaster Hazard Mitigation Grant Program, Flood Mitigation Assistance Program, Severe Repetitive Loss Program, and Repetitive Flood Claims Program; and




